I am writing this letter to share with you possible plans for this upcoming school year and to ask for your help in returning the attached survey. The FDL Ojibwe School's Reopening Plan has been approved by the FDL Reservation Business Committee. Please see our school website at fdlrezk12.com for details of the plan. We are planning to opening at Phase 2, (begins on page 4 of plan), but could move to the Learning at Home program at any time depending on the number of COVID19 cases in the community. Please be prepared for all phases of the plan.

Highlights of the Phase 2 plan is:

- families offered face-to-face instructions, online instruction, or a combination
- 9 students to a classroom
- students stay in assigned classroom throughout the school day
- temperature checks prior to bus entry and building entry
- all staff and students must wear masks/face guard
- 9:00 a.m. school start and 2:00 pm school dismissal
- staggered student entry and dismissal
- after-school programming and community events are canceled
- student showing symptoms will be sent home (please ensure contact info is up-to-date)

We are now requesting your placement choice for your child. When making your decision

please understand:

- You must be prepared to transition to the Learning at Home program at any time.
- Students who attended in the spring of the 2019-2020 School Year will have priority for classroom space. Any new students will follow the FDL Ojibwe School Admission guidelines. All students need to complete <u>Enrollment Forms/Packet for fall enrollment</u>.
- If you choose the Learning at Home program, and later decide you want your child to attend school in person, your child will be placed on a waiting list for a classroom seat if the classroom is at its maximum for student capacity.
- Students must follow social distancing and mask guidelines in the classroom/school or another educational plan may be developed for student.
